#### International Economic Studies

The Bachelor's degree in International Economic Studies (B.Sc.) is a perfect start into a professional career as an economist, whether you aim to work in business, government or academia. The three-year program provides you with all essential knowledge for understanding and analyzing the economy and economic policy. The distinct international perspective of the program reflects the growing importance of international economic integration and emphasizes the comparative study of economic policies. The international perspective is complemented by language courses and an integrated study abroad.



## **Target group**

The program is designed for high-school graduates interested in economics with an international perspective who are looking for a solid foundation for a professional career in business, government, or international agencies. The program also prepares students to pursue graduate studies in economics, business, or public administration. The degree program is taught in English throughout. Therefore, good knowledge of the English language is an essential prerequisite to successfully complete the degree program.

#### **Competencies**

The program provides a sound understanding of the basic principles of economics, accounting, statistics and quantitative analysis. It enables students to understand and analyze specific problems related to international economics and economic policy. This includes the ability to generate a quantitative assessment using the appropriate statistical and econometric methods as well as fluency in a non-native language.

### **Course content**

The compulsory program includes the three topical core areas International Economics, International Business and International Politics, Law, and Society. The core area Tools provides the essentials for quantitative analysis. Further areas include Reflection, Experience, Language and Electives.

## Career opportunities

The curriculum provides you with the required skills to enter a professional position in a variety of institutions that are concerned with economic decisions and economic policy. Potential employers encompass private corporations, the public sector, but also supranational institutions and non-profit organizations, which are increasingly seeking graduates with a background in international economics and international experience.
